

CLIENT DIRECT SERVICES:

ECHOS provides on-site services for healthcare, food, application assistance and other key social services. In 2017, ECHOS provided: 5,034 families (14,222 individuals duplicated) received application assistance, healthcare screenings, domestic violence support and free ESL and computer classes. 12,330 disaster relief services were provided to 7,492 individuals. 29,999 individuals (duplicated) received nutritious food through the food pantry and Saturday food fairs. 2,754 children and adults received vision, glucose, or blood pressure screenings or dental care.

BENEFITS APPLICATION ASSISTANCE:

On-site health education and application assistance for healthcare and other social services- ECHOS provides education about and assistance in completing and submitting applications to State and County medical and social services including: Medicaid/CHIP Perinatal programs - so women can receive appropriate prenatal care. Children's Medicaid/CHIP programs - provides full service medical and dental services for those children whose parents are unable to afford existing medical insurance programs. Harris Health Systems (formerly Harris County Hospital District) Financial Assistance Program ("gold card") - so that uninsured individuals who reside in Harris County can receive discounted services at a primary care clinic rather than the emergency room. HARVEY RELIEF/DISASTER RELIEF ASSISTANCE:

In September 2017, ECHOS was on the front line, assisting victims of Hurricane Harvey. In the early days we provided food, personal hygiene items, metro cards, vouchers, blankets, cleaning buckets and other needed items. We also provided families with ongoing Harvey relief including furniture, utility and rental /mortgage assistance, and gift/grocery cards/food vouchers.
